Jay,

The Janelle Jenkins case was initially declined on 1/29/2015. I do not have a date for the original declination of the Sammy Nichols case in 2015. Both cases were up-dated and re-submitted for consideration by letter dated 3/8/16. They were declined due to lack of evidence of intent, lack of prosecutorial resources for low level felony matters, and because the SBE investigations had the overall positive net effect of causing both voters to cancel their duplicate registrations, making it unlikely they would ever become repeat offenders. These appear to be well cited reasons for declination. The DA's Office stated that they would re-consider prosecution if any of these voters were to re-register in NC and another state again for the purpose of voting twice in an election. Prosecution is always at the discretion of the DA's office. We are satisfied that they gave these cases careful consideration.
