CANVASSING UPDATE

Note: *If you're not in a County/Community Group, you will not be able to take part in either of these activities. Also, all canvassing foot soldiers will be required to have a completed criminal background check before being placed in the field.*

Section 1:

Canvassing Foot Soldiers - visiting homes

This Week (end of Sept) - Training the Trainers

Next Week (first week of Oct) - Training sessions for the rest of us via Zoom or Self-Study - *required in order to participate with our teams

October - Canvassing in the first county.

* This county HAS been selected.

* First county is within 75 miles of the Raleigh/Durham area.

* You'll have the opportunity to canvass as many days a week as you'd like. Our teams will be running 5 days a week for 3 weeks straight.

* We'll need to know if you simply want to be or can provide a driver (such as a spouse).

Goal for County #1: 1,000 sworn affidavits or voter challenges.

Section 2:

Canvassing Keyboard Soldiers - no need to visit homes

The data team can create a list of ballots cast with obvious errors in the November 2020 election in NC.

Therefore, the people in this Canvassing Keyboard Soldiers group will:

1. be given the list, in excel, of likely fraudulent ballots for YOUR county

2. conduct a little research using the internet to make sure each ballot on your list is truly fraudulent (you'll be trained in how to do this),
3. fill out either an sworn affidavit or voter challenge for each ballot that your research shows is truly fraudulent,
4. have each affidavits/voter challenges notarized*,
5. make a copy to turn into the NCAF Canvassing Documentation "Dept",
6. then hand deliver the originals to your county's Board of Elections Director
7. return your excel list back to the NCAF Canvassing Documentation Dept, noting which ballots were indeed challenged.

*Find a Patriot in your county who's a notary who will notarize the documents for you at no charge.

What does the NCAF Canvassing Documentation Dept do with the copies of affidavits/voter challenges?

We make copies and place on the desks of:

- * the appropriate state legislators who are supposed to providing oversight over our Elections,
- * the state legislators who represent your county, *This could be done at the local GOP meeting to get the word out.*
- * the NCGOP Party Chairman, Michael Whatley,
- * the Chairman of your county's Board of Commissioners, which is the elected body who hired your local Board of Elections Director. *This could be done during the public comments period of the Board of Commissioners' meeting to get the word out.*

Press Releases

NCAF will issue periodic press releases to over 200 media outlets to let North Carolinians know the number of fraudulent ballots We the People have found which, in effect, cancelled out their legal ballots.
